3 **SECTION 1. DISPOSITION OF UNCLAIMED MONEY RECOV-**
4 **ERED AT AIRPORT SECURITY CHECKPOINTS.**

5 (a) **DISPOSITION OF UNCLAIMED MONEY.**—Section
6 44945 of title 49, United States Code, is amended by
7 striking “shall be retained by the Transportation Security
8 Administration” and all that follows before the period at
9 the end and inserting “shall be annually transferred, with-
10 out further appropriation, by the Assistant Secretary to
11 nonprofit organizations that operate airport centers in
12 multiple locations throughout the United States to provide
13 a place of rest and recuperation for members of the Armed
14 Forces and their families”.

15 (b) **ANNUAL REPORT.**—Section 515(b) of the De-
16 partment of Homeland Security Appropriations Act, 2005
17 (Public Law 108–334; 118 Stat. 1318; 49 U.S.C. 44945
18 note) is amended—

19 (1) by striking “the Committee on Transpor-
20 tation and Infrastructure of the House of Represent-
21 atives” and inserting “the Committee on Homeland
22 Security of the House of Representatives”; and

23 (2) by striking “and specifically how the un-

4 **SECTION 1. SHORT TITLE.**

5 *This Act may be cited as the “TSA Loose Change Act”.*

6 **SEC. 2. DISPOSITION OF UNCLAIMED MONEY RECOVERED**

7 **AT AIRPORT SECURITY CHECKPOINTS.**

8 (a) *DISPOSITION OF UNCLAIMED MONEY.*—Section
9 44945(a) of title 49, United States Code, is amended—

10 (1) by inserting “after the date of enactment of
11 the TSA Loose Change Act,” after “title 31,”;

12 (2) by striking “shall be retained by the Trans-
13 portation Security Administration” and all that fol-
14 lows through “this chapter” and inserting “shall be
15 annually transferred, based on requests for proposals,
16 without further appropriation, by the Assistant Sec-
17 retary to nonprofit organizations that operate airport
18 centers in multiple locations throughout the United
19 States to provide places of rest and recuperation for
20 members of the Armed Forces and their families”;
21 and

22 (3) by adding at the end the following new sen-
23 tence: “The Assistant Secretary shall ensure that the
24 name of each nonprofit agency to which funds are

1 *transferred under this subsection is printed in the*
2 *Federal Register.*”.
